Introduction to NORDEFECO

Nordic Defence Cooperation (NORDEFECO) represents a long tradition of cooperation among the Nordic countries – Denmark, Finland, Iceland, Sweden and Norway. The armed forces of the Nordic countries share a common approach, making broad cooperation both possible and preferable. This cooperation is based on the conviction that there is a lot to be gained through shared experiences, shared cost, joint solutions and joint actions.

The NORDEFECO structure is a cooperation structure, not a command structure. Cooperation activities initiated from top or bottom are facilitated and agreed within in the structure, but the actual realization and participation in activities remain national decisions.

Once a cooperation activity is implemented, it will be run by the regular, existing national chain of command. A NORDEFECO agreement will decide upon a framework or lead nation concept for the activity. Examples of this could be educational cooperation, where responsibility is divided between the nations or a common exercise plan with a rotating host nation scheme for major exercises.

The NORDEFECO Peace Support Operations Education & Training programme is an excellent example of how the Nordic nations can cooperate. By dividing the responsibility for the different types of courses, together with sharing of the nations' national instructors it was possible to reach international top-level. This had not been possible if the nations would have attempted to set-up the courses individually.

The main aim and purpose of the NORDEFECO is to strengthen the participating nations' national defence, explore common synergies and facilitate efficient common solutions.

Nordic Provost Marshal Course (PMC)

Aim

The aim of the course is to impart such knowledge and attitudes to students from Nordic and other countries that he/she is able to perform the duties as Provost Marshal, working in a Provost Marshal staff or perform as Legal Advisor in an international operation.

The course is intended for personnel serving as Provost Marshal, Legal Advisor or in a Provost Marshal staff.

Performance/Learning objectives

Upon completion of the course the students should be able to:

- ★ Work as PM or in a PM staff on Bde and BG level.
- ★ Understand how SOP/SOI, MOU, ROE, Law of Armed Conflicts etc. impact on PM guidance and advice in an international environment.
- ★ Understand paradoxes and dilemmas in connections with National and International regulations and caveats in connections with investigations.
- ★ Higher understanding of Bde/BG Commanders expectations to his PM and the Military Police unit in connection with operations.

Target Audience

To be eligible to attend the course, nominees must fulfill the following criteria:

- ★ Student must be Military Police Officers (OF-2 or higher) or Legal Advisors.
- ★ Students must have served as a Military Police officer (except Legal Advisors).
- ★ Students must have a very good knowledge of English.

Course duration

5 days

Course cost

Payment is € 130,- pr. day and will cover meals, accommodation and all course related social arrangements.

United Nations Military Police Course (UNMILPOC)

Aim

The aim of the course is to impart such knowledge and attitudes to officers from the Nordic and other countries making him/her able to perform MP-Officers functions or to perform MP Shift Commander's functions in a Multinational MP unit within a UN, NATO or coalition operation. The course is meant to give the students an introduction to the work as Military Police in a Multinational MP unit in an international operation.

Performance/Learning objectives

Upon completion of the course the students should be able to and understand the following:

- ★ UN organization, tasks and activities related to peace support operations, including support from military organizations (NATO).
- ★ Military Police authority in different types of UN and NATO missions, incl. ROE, Law of Armed Conflict and other legal documents.
- ★ Operational planning and MP Operations including:
 - Mobility Support Functions
 - Law Enforcement Functions
 - Security Functions
 - Detention Functions
- ★ Military Police Administration in UN and NATO operations.
- ★ Radio Communications and Military English.
- ★ Historical, political, climatic and cultural conditions in potential UN or NATO lead mission areas, including gender issues.

Target Audience

To be eligible to attend the course, nominees must fulfill the following criteria:

- ★ Student must be Civilian or Military Police trained or a Legal Advisor.
- ★ Student must have a very good knowledge of English.

Course duration

17 days (3 weeks including the weekend between week one and two).

Course cost

Payment is € 130,- pr. day and will cover meals, accommodation and all course related social arrangements.

International PSYOPS Basic Course (IPBC)

Aim

The aim of the course is to provide the individual student with the basic understanding of the definition, aim, components principle tasks, functions and organization of NATO PSYOPS in general.

Performance/Learning objectives

Upon completion of the course the students should be able to:

- ★ Enter following specialist PSYOPS courses in order to be able to assume PSYOPS duties within formations and staffs with focus on battalion and brigade level.

THE FINNISH DEFENCE FORCES INTERNATIONAL CENTRE (FINCENT)

The Finnish Defence Forces International Centre FINCENT is nationally and internationally known and recognized forerunner, expert and active participant in crisis management education and training.

FINCENT organises military crisis management training for command and expert personnel in United Nations, NATO, European Union and African Union led crisis management operations. FINCENT also focuses on assuring the quality of training and supervising crisis management education criteria.

The mission of FINCENT is to execute and conduct the international training of leaders and experts in crisis management in cooperation with its national and international partners. Since 2015, FINCENT has been the Department Head for the NATO Military Contribution to Peace Support (MC2PS) Discipline. In this role FINCENT monitors and evaluates the range, execution and practices of crisis management training on a global scale and defines training solutions and responsibilities. FINCENT also supports other Finnish Defence Forces units with its expertise in terms of training and evaluation.

FINCENT is located on the military island of Santahamina, some 10 kilometres from Helsinki city centre with good public transport connections. The Santahamina Building

and some other departments and services of the National Defence University in the National Defence University's campus area offers modern and needed premises for FINCENT. The building has one auditorium and several classrooms and groups study rooms with free Wi-Fi connection. There is also a course hotel for 65 people with laundry facilities, kitchens, gym and sauna. Wide variety of sport facilities and equipment are available to the students during the course. The National Defence University Library and a café are located on the ground floor.

FINCENT has been qualified by the United Nations (UN Certificate of Training Recognition), NATO (NATO ACT Quality Assurance) and Finnish National Defence University (NDU Assurance of Training Quality). The crisis management training conducted by FINCENT has been granted the ISO 9001 quality certificate.

FINCENT was founded in 1969 as the first peacekeeping training centre in the world.

United Nations Military Observer Course (UNMOC)

Aim

The aim of the course is to prepare military officers for service as UN Military Observers in any on-going or future UN Peacekeeping Operations.

Performance/Learning objectives

Upon completion of the course the students will be able to do the following:

- ★ Demonstrate the knowledge, skills, and attitude of the role of a United Nations Military Observer in the UN Multidimensional Integrated Mission Concept, understanding the organizational structure of the mission, and the roles of mission components (civilian/police/military components) including the UN Country Team and other mission actors (i.e., humanitarian aid, development)
- ★ Apply the different knowledge, skills, and attitude of a UN Military Observer in relation to the UN Multidimensional Integrated Mission Concept.

Target Audience

To be eligible to attend the course, nominees must fulfil the following criteria:

- ★ They must be a nationally trained officer with more than five years of working experience (CAPT to COL) or nationally trained female warrant officers or lieutenants with more than five years of working experience
- ★ They must have a working proficiency in the English language
- ★ They must have a valid driver's license (for a manual gearbox)
- ★ They must be physically fit
- ★ They must have basic computer skills

Course duration

19 days

Course cost

The course costs €2470 and this covers meals, accommodation, and all course-related social arrangements.

UN Comprehensive Protection of Civilians Course (UNCPOC)

Aim

The aim of the UNCPOC is to strengthen the understanding of the participants on how protection of civilians (POC), child protection, and conflict-related sexual violence considerations affect military planning processes at the tactical level. The course provides an in-depth examination of the core protection tasks that are performed by personnel with dedicated protection functions in order to implement the mandate effectively in the field.

Performance/Learning objectives

- ★ To demonstrate knowledge of the comprehensive protection of civilians (CPOC) according to the protection of civilians in the United Nations Peacekeeping Handbook
- ★ To identify the legal framework relevant to the CPOC according to mission mandate
- ★ To integrate CPOC considerations into the military decision-making process at the tactical level, according to the operational framework and with the support of Subject Matter Expert
- ★ To perform collaboration with components and relevant actors in a UN peace operation environment
- ★ To apply the CPOC concept, ensuring mission success according to the mission mandate and The Protection of Civilians in United Nations Peacekeeping Handbook

Target Audience

This course has been designed for military/police/civilians working at the tactical level in UN PKOs and IO/NGOs working with the UN in these operational environments.

To be eligible to attend the course, applicants must fulfil the following criteria:

- ★ They must be a military officer (OF-2 through OF-5) or a civilian or police equivalent working in areas related to crisis management in the wider context, currently working in a crisis area, or they can be prospective participants in future operations or missions
- ★ Personnel working in relation to protection functions who are required to or positioned to act on the POC in their respective organizations
- ★ IOs and NGOs
- ★ Educational background: An academic degree (EQF 6 and 7) or an equivalent military education
- ★ Participants shall be experienced experts on their own field
- ★ Language proficiency: UN Level III Working Language Proficiency or the equivalent advanced language competence. The students are expected to present the findings of syndicate work both verbally and in writing.

Female candidates are strongly encouraged to apply to this course.

UN Peace Operation Security Management Course (UN POSMC)

Aim

The aim of the course is to prepare military, police, and civilian personnel for security management-related interaction and co-operation between different components of ongoing and future UN Peace Operations. The UN POSMC aims to enhance the knowledge and critical understanding of the nature of security as a comprehensive and vital part of operational capabilities and its integrated processes in a joint multinational environment.

The UN POSMC focuses on UN Peace Operation security management co-operational procedures and activities on sector level / security area level.

Performance/Learning objectives

- ★ To describe the nature of the security environment and framework of UN Peace Operations and UN presence in the field
- ★ To discover the UN Security Management System and UN Security Policy functions and procedures of different components for improved Security Risk Management Measures in UN Peace Operations
- ★ To experiment with security management co-operation in UN Peace Operations

Target Audience

To be eligible to attend the course, applicants must fulfil the following criteria:

- ★ The applicant is serving as or will serve as:
 - A UN military component (leadership, military liaison officers, force protection officers, operations officers, intelligence, CIMIC officers, military advisers)
 - A UN police component (leadership, planning officers, operation officers, intelligence, FPU leadership)
 - A UN military observers component (S/CMO, planning officers, sector liaison officers, staff security officers, team site leaders, observer group leadership)
 - A UN country team component / a UNDSS security expert / some other UN security personnel (operational/SA level; SA, SIOC officers, FSCO, or the equivalent)
- ★ (Rank) level: OF3/P3–P4 and above
- ★ English language proficiency: 3-2-3-2 (in accordance with STANAG 6001), UN III, or the equivalent

- ★ Depth of knowledge: The course aims at Proficiency Level 200+ (NATO) and 3 (UN), which is required to become functional and to successfully perform a series of tasks independently, with minimal oversight. With on-the-job training and working experience, levels 300 (NATO) and 4 (UN) level can be reached.

NATO and UN Peace Operations Course (NATO UN POC)

Aim

The aim of the Approaches to Protection of Civilians in NATO UN POC is for civilian and military participants to develop a practical understanding of the role of the UN, NATO, and civilian organizations as protection actors in operations. The course focuses on how to protect civilians from threats of physical violence, including harm from their own actions. The course also enhances the military's understanding of how military options impact on civilians and how the military can support other non-kinetic actions in order to minimize the negative impacts of conflict on civilians.

Performance/Learning objectives

- ★ To demonstrate knowledge of the military's role in protecting civilians, civilian objects, and services
- ★ To analyze the operational environment
- ★ To conduct threat and risk analysis with regard to threats of physical violence for civilians in military operations
- ★ To apply protection concepts in ensuring the mission's success

Target Audience

This course has been designed for staff working at the strategic or operational level in NATO, with NATO Partners or UN T/PCC Nations, and IO/NGOs working with NATO or the UN in these operational environments:

- ★ Military officers (OF-3 through to OF-5) or equivalent civilians
- ★ English language proficiency 3-2-3-2 (in accordance with STANAG 6001) or the equivalent

NATO Logistics Introductory Course (NLIC)

Aim

The aim of the course is to provide foundational knowledge of NATO logistics, policy, principles, concepts, and the doctrine of theatre-level logistics in operations. It also consists of a planning module on the tactical level of the NATO operations process of the development of a logistics support plan in a NATO-led multinational operation or exercise.

Performance/Learning objectives

- ★ To recognize NATO and NATO logistics fundamentals under supervision and with assistance
- ★ To recognize the scope of NATO logistics and its functions under supervision and with assistance
- ★ To describe key aspects of multinational logistics cooperation and NATO's approach to partner nations and logistics education, training, exercises, and evaluation under supervision and with assistance
- ★ To recall the role of enabling processes and supporting functions under supervision and with assistance
- ★ To familiarize the NATO logistics planning process in multinational operations or exercises under supervision and with assistance
- ★ To recognize the tactical level of the NATO operations process of the development of a logistics support plan in a NATO led multinational operation or exercise under supervision and with assistance

Target Audience

Officer level: OF-1 through to OF-5; CIV: the equivalent
NCO: OR-7 through to OR-9; CIV: the equivalent

Course duration

10 days + 1 day of pre-study prior to the course

Introduction to NATO Military Partnerships Course (NATO IMPC)

Aim

After successful completion of the course, students are able to contribute to military partnerships in NATO in their role as a partner nation officer or a member of NATO staff working with partnership programs.

Performance/Learning objectives

Upon completion of the course the students will be able to:

- ★ Recall the NATO organization
- ★ Explain partnership frameworks
- ★ Explain the interconnectivity of the NATO structure
- ★ List the main steps and products in the process sequences (who does what, at what level, and at what time)
- ★ Explain the RLA, DLE, and FLE process
- ★ Explain what ITR is, and which nations it applies to
- ★ Contribute to processes and documentation
- ★ Contribute to the recommended list of activities (RLA, DLE, and FLF processes or individual tailored road maps)
- ★ Contribute to the planning processes
- ★ Demonstrate the importance and value of complying with NATO partnership frameworks and processes
- ★ Comply with MC D&G and MPD management guidance
- ★ Explain their role and responsibilities in the process

Student Criteria

To be eligible to attend the course, nominees must be:

- ★ Officers, NCOs, or defence civilians of NATO working with partnership programs
- ★ Officers or defence civilians from the Partnership for Peace (PfP), the Mediterranean Dialogue (MD), the Istanbul Cooperative Initiative (ICI), and Partners across the Globe (PatG) countries working with a NATO military partnership
- ★ OR8–OF6 or the civilian equivalents

An introduction to NATO ADL course or equivalent assigned material is a pre-requisite. Participants will have the opportunity to take the ADL course before the course starts. Working experience in NATO or in partnership programs is not required.

Comprehensive Operations Planning Course (COPC)

To prepare participants to contribute to NATO's operations planning process, either as an operational-level or functional-area planner, while serving within a joint operational-level headquarters, applying the principles of the Comprehensive Operations Planning Directive (COPD).

Performance/Learning objectives

- ★ To understand NATO's OPP Strategic Environment
- ★ To demonstrate the principles of operational art within the COPD
- ★ To prepare and analyze courses of action
- ★ To describe the remaining phases of NATO's OPP

Safety Officer Course (SAFOC)

Aim

The focus of the SAFOC is on the Safety Management Process including military in-service and occupational safety in Peace Keeping Operations, and Peace Support Operations, and the SAFOC is approved by the Nordic Defence Cooperation (NORDEFECO).

The aim of the course is to prepare students from the Nordic countries to serve as safety managers or officers within a tactical-level (Bn/Bde or a corresponding level) headquarters while applying the Operational Planning Process based on the Comprehensive Operations Planning Directive and the principles of a comprehensive approach .

Performance/Learning objectives

Upon completion of the course, the students should be able to:

- ★ Comprehend the nature of safety as a vital part of operational capabilities and its planning process, as well as how to improve operational effectiveness
- ★ Comprehend safety situational awareness as part of the common operational picture
- ★ Apply the risk management process
- ★ Apply and understand safety measures in order to support operational safety (Force Protection)

Target Audience

- ★ The primary training audience is identified as military officers (OF 2–3, OR 7–9) who have or will be appointed to positions in HQs on the tactical level; civilian staff officer equivalents are also eligible for nomination
- ★ English language proficiency: 3-2-3-2 (in accordance with STANAG 6001) or the equivalent
- ★ National staff experience
- ★ Basic knowledge about military operations and staff work
- ★ Basic knowledge of safety management

Peace Support Operations Co-Operation Course Information (PSOCC)

Aim

The course prepares nationally trained civilians, police, and military officers who are heading for peace operations for coordination, liaison, and cooperation tasks. The course develops and improves the human interaction and working skills of the individual student with an emphasis on coordination, liaison, cooperation, media awareness, and information management. This will enable the participant to work in a multicultural and complex environment and enhance interoperability.

Performance/Learning objectives

- ★ To explain different actors and their role in a multidimensional peacekeeping operations mission environment with an emphasis on guidelines, procedures, and responses to violations of cross-cutting themes on a tactical level
- ★ To conduct liaison activities with different actors, implementing UN integrated in a multidimensional peacekeeping/support operations mission environment with an emphasis on guidelines, procedures, and responses to human rights violations of cross-cutting themes on a tactical level

Target/Training Audience

- ★ Military officers / non-commissioned officers (NCOs) who conduct meetings, liaison, cooperation, and coordination activities (staff officers, unit commanders, platoon commanders, liaison officers, etc.; Levels: OF1–OF3, OR7–OR9)
- ★ Police and civilian personnel who are interested in improving knowledge and practical skills in interaction with military and international and local actors in a complex environment

NODEFIC Logistic Training Concept

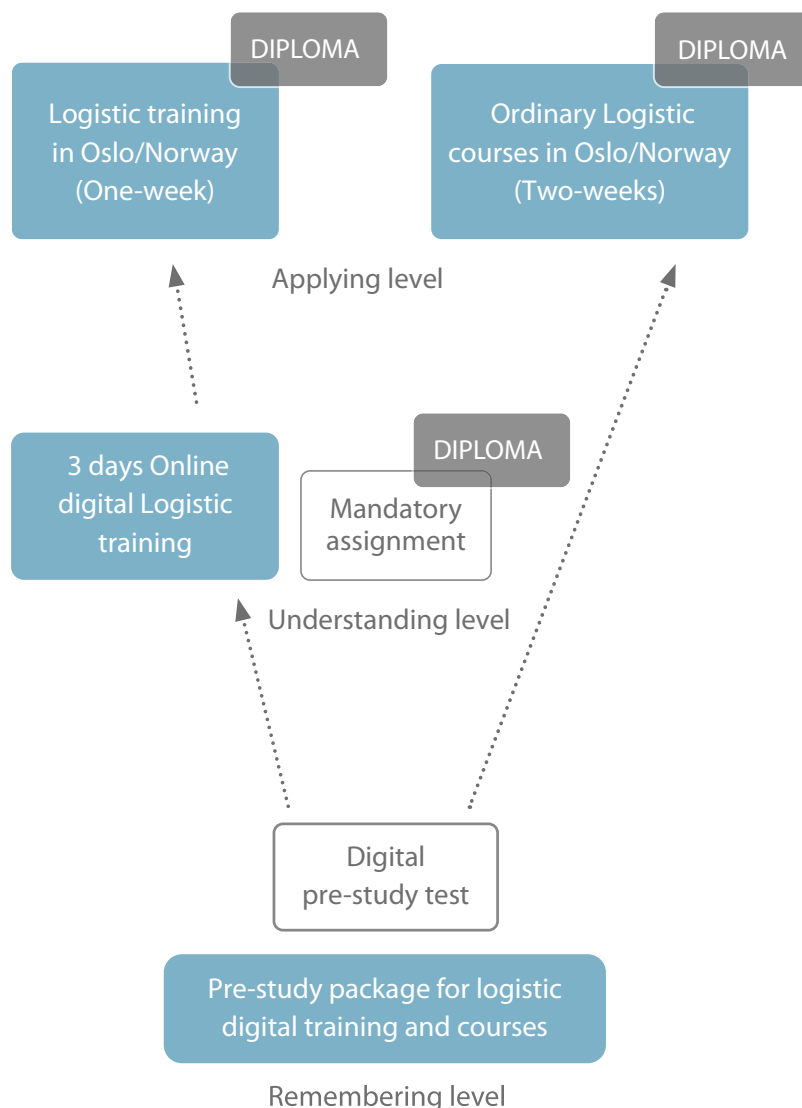
The NODEFIC logistics training is based on two different education methods. Both methods start with a pre-study package. The pre-study will give the participants a **remembering** level of knowledge within basic logistics.

Then either directly to our ordinary two-weeks course in Oslo Norway, or through a combination of online digital training and a shorter training in Oslo Norway.

The standard course will give the participants an **applying** level of knowledge – be able to use the knowledge to plan and solve logistic tasks.

The online digital training, together with the pre-study package is a stand-alone course that will give the participants an **understanding** level of knowledge – be able to use the knowledge to explain the logistic concept or structure.

For those who want deeper logistic education we recommend our one-week training in Oslo/Norway. This training (together with the online digital training) will give the participants an **applying** level of knowledge – be able to use the knowledge to plan and solve logistic tasks.



Online digital training description to the courses: UN- / NATO logistics and INTMOV P

Aim

(1) The aim of the three days online digital training is to give the participants an introduction to, and logistic knowledge level (understanding level) to all areas of the United Nations- or NATO logistics / the UNCOE system / the INTMOV P characteristics (depended on what online digital training you attend).

(2) The three days online digital training, together with the pre-study package is a stand-alone training that will give the participants a logistics knowledge level to solve specific logistic tasks in the framework of United Nations or NATO – being able to use the knowledge to explain logistic concepts or structures.

SWEDISH ARMED FORCES INTERNATIONAL CENTRE (SWEDINT)

SWEDINT is the Swedish Armed Forces' international centre, a leading competence centre for integrated education and training, offering a substantial number of comprehensive courses every year. Focus for the provided courses are planning processes and methods primarily aimed towards UN missions at staff headquarter and sector level, as well as enhanced NATO and EU interoperability at the operational and higher tactical levels. Co-located with SWEDINT is the Nordic Centre for Gender in Military Operations (NCGM) and annually, around 700 participants attend either the centres' residential courses, the courses provided online from one of the two broadcast studios, or the Mobile Education and Training Team (METT) courses held in various parts of the world.

Swedish experience of Peace Support Operations (PSO) started in the Middle East as early as 1948 and the first Swedish battalion under the UN flag was deployed in 1956 in Gaza, followed by UN Mission ONUC 1960 in Congo. Cooperation on peace support operations has often been carried out with a regional approach. The Nordic Defence Cooperation's collaboration on international courses also includes sharing instructors and co-conducting courses.

The emphasis on integration between all actors involved in an international mission/operation is based on the fact

that modern conflicts require a comprehensive approach to have any chance of being successful in establishing a sustainable peace.

SWEDINT provides education and individual training to military, police and civilian personnel, with focus at the operational level. We do this in order to enable them to make a difference in crisis and conflict areas in missions led by the United Nations, European Union, North Atlantic Treaty Organisation and other organisations SWEDINT is well recognised as an institution educating and training staff for multinational military missions/operations and is also, since 1999, recognised by NATO as a Partnership Training and Education Centre (PTEC).

JSC participants must have a NATO RESTRICTED Security clearance for this course (residential or online) and when present actively demonstrate participation with questions, sharing experiences and knowledge, and be able to access and use the NATO approved platform: Microsoft Teams (MST).

Senior Joint Synchronisation Course (SJSC)

Aim

The aim of the course is to enhance the capacity of the Chair of Boards and Working Groups to undertake their roles and responsibilities for Joint Synchronisation more effectively.

Performance/Learning Objectives

Upon completion of the course the participants should be able to:

- ★ Apply key principles of NATO doctrine on joint and campaign synchronisation topics.
- ★ Coordinate timely transition of plans into actionable orders.
- ★ Synchronise execution and adjustment of operations.

NATO Land Tactical Planning Course (NLTCP)

Aim

This course enables NATO staff and partners serving at tactical level, within headquarters at the land component command level and below (corps- division- or brigade level) or staff directly involved in land tactical level planning, to apply the planning principles through the use of operations planning processes, procedures and methodologies.

Performance/Learning Objectives

- ★ Summarise the activities performed during the main steps of NATO's Tactical Planning for Land Forces (APP-28)
- ★ Execute a new planning effort based on a Warning Orders (WNGOs)
- ★ Analyse a crisis in order to determine the necessary tactical conditions to be achieved
- ★ Apply the divergent analysis and deductions from Mission Analysis into convergent, cohesive and complete solutions in the form of draft Courses of Actions (COAs)
- ★ Identify the difficulties, coordination issues, or probable consequences of planned actions for each COA being considered
- ★ Conduct COA decision brief

The overall purpose of NATO LLSOC is to enable Lessons Learned (LL) professionals to execute and manage their organizational roles and responsibilities as LL Staff Officers (LLSO) and LL Point of Contacts (LLPOC), in accordance with the structure, process, tools, and training and sharing Lessons defined in the Bi-SC Directive 080-006 for LL, thus contributing to the development of a LL Management Capability within the NATO Alliance.

Performance/Learning Objectives

Upon completion of the course the participants should be able to:

- ★ Manage a NATO lessons-learned programme
- ★ Select and understand basic analysis techniques
- ★ Restate the functions of a NATO Lessons Learned Portal
- ★ Explain a HQ/UNIT LL capability assessment
- ★ Manage the LL process in Collective Training & Exercises and Operations

Prison and Probation Officers Course (PriPOC)

Aim

The purpose of PriPOC is to prepare correction personnel for service within a Peace Operation, led by UN or other multilateral organisation. The course provides basic knowledge on the UN system and focus on the complexities involved in strengthening national correctional institutions in post-conflict environments, in accordance with international human right standards. Additionally, the personnel will receive basic security awareness.

Performance/Learning Objectives

After completed course the students will be able to:

- ★ Explain the basics of the UN system and the principles of UN Peace Operations
- ★ Demonstrate understanding of the role of corrections in a Peace Operation and the concept of supporting peace and security within broader Rule of Law and security sector reform efforts

Predominately on Division/Force Head Quarter/Brigade/Sector level. Further, the aim of the course is to develop and improve the staff working skills of the individual student and his/her overall knowledge and understanding of a UN Peacekeeping Operations (PKO) multidimensional / integrated mission in order to be better prepared for the situation and challenges of a UN PKO mission once deployed.

Performance/Learning Objectives

The course aims to prepare staff officers for duties at the Force and Sector HQ levels in UNPKOs, using the UN Staff Officers Specialised Training Material (SO STM).

On completion of the course, participants will be able to:

- ★ Contribute efficiently to implement military aspects of UN peacekeeping mandates in accordance with DPO principles and guidelines.
- ★ Perform your military functions in an effective, professional and integrated manner
- ★ Demonstrate the core values and competencies of the United Nations.

- ★ List the range of protection actors that operate alongside peace-keeping operations
- ★ Explain the six grave violations against children in conflict, to other actors involved in Child Protection
- ★ Describe the range of threats facing children and the role of peace-keepers in protecting children from those threats
- ★ Acquire the tools necessary to incorporate the Child Protection Specialized Training Materials into their national training systems or in-mission training once deployed to peacekeeping operations

The course program is based on the United Nations Integrated Disarmament, Demobilization and Reintegration Standards (IDDRS), as well as practitioners best practices. The course is not intended as an introduction to DDR but rather as a continuation of existing introductory courses.

- ★ Given a scenario for a specific UN mission, implement the DDR concept in an integrated, gender-responsive DDR programme that responds to the needs of ex-combatants, families and receiving communities
- ★ Given the reference documents, assess a new DDR program according to the DDR concept
- ★ Given a UNSC Mandate and a Concept of Operations (CONOPS) for a mission, estimate human, logistical and financial operational requirements for a DDR program

NORDIC CENTRE FOR GENDER IN MILITARY OPERATIONS (NCGM)

NCGM is a knowledge hub on gender in military operations, guided by a steering committee and hosted by SWEDINT. NCGM strives to enable actors to apply gender perspective to every situation in order to increase operational effectiveness.

Having gender perspective is to be able to detect when women, men, girls and boys are being affected differently by a situation or an operation because of their gender. Applying gender perspective in planning, execution and assessment of military operations and activities ensures that we focus on how to best protect all civilians, especially vulnerable groups in specific situations.

Since its establishment in 2012, NCGM has provided international training courses to a wide audience from senior military leadership to Gender Focal Points for troops from all regions of the world. Most courses are conducted in Sweden but audience-tailored training can also be provided

through Mobile Education and Training Teams. Since the outbreak of the COVID 19 pandemic, NCGM has transformed its residential courses to online courses and will continue to provide some course iterations online in the future as well. NCGM gathers and publishes lessons learned and best practices, participates in international conferences and seminars and has built a global network and pool of experts on gender in military operations. NCGM collaborates closely with the Nordic countries, NATO, UN, EU, other IOs, NGOs and military training centres globally.

Since February 2013, NCGM has the role as NATO Department Head for Gender in Military Operations. In this capacity, NCGM translates NATO's strategic and operational requirements into an education and training program and offers support to NATO Nations and Partners with subject matter expertise.

It also focuses on how to argue in favour of integrating gender perspectives at political and military strategic levels.
